General information

Exhibition participation fee

550€ + VAT 20%: 660€ per company

Included in the fee: - Standard booth 9 m², table, 2 seats, coffee breaks and lunches for 2 persons

The booth rental will be invoiced upon the Organizer's receipt of the Order form. The term of payment is 13.02.2017

General terms

Allocation of stands

The chronological order receipt of "Orders for Exhibition Space" and the following payment of rental fees will establish the stand allocation priority.

Force majeure

In case of war, mobilization, strike, lock-out, fire, severe weather conditions, regulations of the authorities or other circumstances beyond the control of the Organizer, that might render it impossible or difficult to carry through an arrangement, the Organizer shall be entitled to transfer, in whole or in part, the arrangement to other premises, to postpone the implementation of the arrangement to another time or to cancel. The arrangement and the Organizer shall not be liable to pay compensation to the Exhibitor or be bound to reimburse the stand rental paid.

Transport / Forwarding agent

The official forwarding agent of the exhibition is Reisieksperti AS / Conference Expert.

The forwarding agent will receive the name, telephone number and address of every contracted Exhibitor. The Exhibitor will be contacted for further arrangements regarding transportation, storage of goods before and after the exhibition etc.

The forwarding agent will be solely in charge of all dealings with the Customs Authorities.

Publicity

The placing or handing out publicity materials, samples etc outside the area of the stand is not permitted. Political propaganda is prohibited. Use of loudspeakers and exhibition films, slides, video etc may only take place after obtaining written permission from the Organizer and must never constitute a nuisance to the surrounding stands and lecture halls.

Transfer of space

Exhibitors are not permitted to sublet their stand or lend it to a third party, either in part or as a whole. No changes of the stands among the exhibitors may take place without a written consent of the Organizer.

Responsibility

The Exhibitor shall be responsible for any damage done to the premises, fixtures or injuries to persons caused by the Exhibitor, his staff or his exhibited articles and exhibition material.

Claims

Any complaint shall be made forthwith and no later than at the closing of the exhibition and shall be sent by registered letter to the Organizer.

Adoption of Estonian law

The Exhibitor recognizes by his signature that any legal matter between him and the Organizer arising out of the contract – including the interpretation of the contract entered into between himself and the Organizer and the settlement of claims with regard to the Exhibitor's responsibility to pay compensation – shall be adjudicated and decided according to Estonian law.

Alteration of the regulations

The Organizer reserves the right to alter the present regulations with immediate effect in case of orders from the Authorities or other compelling reason makes it necessary.

Cancellation terms

The Organizer must receive notification of cancellation of exhibition space in written consent of the Organizer. The refund policy is:

50% refund for cancellations received before 10st February 2017.

No refund will be made after 11st February 2017.

Security

The safekeeping of the exhibitor's property while building, dismounting and during the fare is the responsibility of each exhibitor.
